#### **Publication Guidelines**

Font: Palatino Linotype, 11

Line spacing: 1

**Margins** (in cm): Top: 5.75, Bottom: 5, Left: 4.25, Right: 4.25

**Paragraph**: Indent all paragraph beginnings 1.25 cm.

**Length**: 3500 – 7500 words

**Languages**: English, French, German, Spanish, Italian, Russian (irrespective of the language of the text, the abstract and keywords will be in English)

Title: BOLD CAPITALS, CENTERED, 11

Author's Name: UNDER TITLE, BOLD CAPITALS, CENTERED, 9

Leave one space between the title and the author's name.

#### Affiliation:

The authors will make use of an asterisk which will introduce the first note (not numbered) mentioning the Institution of the author and his e-mail.

**Abstract**: font 9, 10-15 lines/ 100-200 words

The abstract, followed by 5-7 Keywords (both in English) will precede the text of the article; before the text of the abstract, the word *Abstract* will appear (centered, font 9, italics).

If the text is in a language other than English, the Abstract will be preceded by an English translation of the article title (in capitals), font 9.

**Notes:** numbered footnotes, font 9

**Headings**: The article should be divided into numbered sections (1. Heading bold) and sub-sections (1.1. Heading; 1.2. Heading – Italics, Bold; 1.2.1. Heading – only Italics). Headings will have two spaces above and one space below.

## **Examples and quotations:**

Grammatical examples or text excerpts offered for analysis will be written in italics, indented (1.25 cm). Examples should follow the following format, preceded by one space above and followed by one space below:

- (1) What a beautiful day it is!
- (2) Such a nice hat!

In-text quotations of previous scholars will be placed between double quotation marks: as Reddick states "....". Quotations lengthier than 3 lines (40 words) should be displayed indented (1.25 cm), in text, without quotation marks.

### **References**:

References made in the text should have the following format: Johnaston (2005: 23-24), Starnes and Noyes (1946); leave one space between the year and the page/ the pages, after colon. Authors solely are responsible for the accuracy of their references.

All references will be placed at the end of the article under the heading Bibliography. The heading will be written in BOLD CAPITALS, CENTERED, font 9. The bibliography should be written with font 9, second line (or the following lines) hanging (1.25 cm).

Different works by the same author in the same year will be marked a, b, c.

Surname, Name (Year), *Title*, Publishing House, Publication Place.

Quirk, Randolph, Sidney Greenbaum (1989), A University Grammar of English, Longman, Essex.

Articles in journals:

Surname, Name (Year), "Title", in *Journal*, Volume (only Roman numbers), Number (only Arabic numbers), Pages.

Spear, Karen (1983), "Building Cognitive Skillsin Basic Writers", in *Teaching English in the Two-Year College* 9, pp. 1-98.

Articles/ Chapters in collective volumes:

- We should use English quotation marks ("") when the article cited is in English; Romanian quotation marks ("") when the article cited is in Romanian; French quotation marks (« ») when the article cited is in French.
- The authors are requested to supply an auto-bio-bibliographical note in English (approximately 10-15 lines).
